

AVALARA AVATAX INTEGRATION AUTOMATES AND SIMPLIFIES SALES TAX COMPLIANCE.



CrescentOne is now part of Avalara's "Certified for AvaTax" program, which provides Open Connectors that perform at the highest level and provide the best possible customer experience.

Avalara's Certified partners must pass a series of criteria developed by Avalara to ensure the connector's, security, stability, performance and reliability, helping to ensure customers benefit from a seamless experience with Avalara's tax compliance solutions.

As a result of this partnership, CrescentOne customers can now optionally choose to call Avalara's AvaTax capabilities from within the CrescentOne business applications for:

- Address verification, and,
- Sales & Use tax calculations,

More specifically,

When Avalara AvaTax Address validation is enabled, Customer delivery addresses will be checked and validated by Avalara when:

- A CrescentOne Customer Ship to Location is added or the address associated to a Ship to Location is updated.
- A One-time Ship to Address is used in the CrescentOne Billing process.

When AvaTax Sales Tax calculations are enabled, the Sales and Use Tax rates and amounts derived in the following processes will be determined by Avalara Avatax and parsed back the CrescentOne billing documents and used instead of those calculated by standard CrescentOne Tax Calculations:

- Bill Sales Orders
- Bill Credit Memo's
- Bill Debit Memo's
- Contract Management Billing
- Material Supply Billing
- Bill Customer Releasing
- Field Service Order Billing
- Contract (Rolling Agreement) Billing





The solution is ready to go 'Out of the box' and requires little set up or technical skills.

Once licensed:

- The various capabilities available are enabled through simple options within the application screens.
- All Partner API's and Open Connectors including the Avalara Avatax integration can be quickly and easily set-up using the 'Partner API's and Open Connectors Maintenance' screen.
- All calls made for each API and Open Connector are logged and show request and response details that identify all successes, failures, and reasons for any failures.
- The logging capabilities (as with all features of the Avalara integration) were assessed and certified by Avalara who have vast experience in making sure their solutions are deployed in a secure and stable manner.

For certain states and Jurisdictions Sales and Use Tax calculations can be very complex.
